During this inspection the following possible compliance issues were observed: 1002.f.(2)F Vehicle Tracking: Tracking pad not installed or installed improperly or not adequately maintained to prevent track of material offsite. CA date 2-2-2022. See attached photos. Location: frozen mud, Weather: cloudy and cold. I spoke with Jr. Salinas Site Supervisor about the vehicles tracking of dirt/mud when leaving location, He said that they have been sweeping regularly and the sweeper had just left prior to my arrival. The ground thawed out yesterday afternoon and he had to call out a skid steer along with a sweeper to clean the road. He is looking to get tracking pads set to help with tracking off site. A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
