It was observed in this inspection that final reclamation of the Location has not been performed pursuant to 1004 Rules; well and associated production equipment have been removed, however, 1004 final reclamation requirements including, but not limited to, recontouring/regrading and revegetation have not been conducted.

Undesirable plant species remnants/debris (Russian thistle, Knapweed) also observed on the Location.

Comply with 1004 Rules and conduct final reclamation. Conduct weed management to prevent further establishment and spread of Undesirable and Noxious Plant Species.
