Inspections required Operator to comply with 1004 Rules by 11/30/2020.</p> <p>Location remains out of compliance with COGCC Rules and corrective actions; it was observed in this inspection that the Operator appears to have conducted some work including "pot-holing" along the access road; however Location and access road have not been recontoured/regraded and reclaimed in accordance with 1004 Rules.</p>

<p><b>STORMWATER COMMENTS</b></p> <p>Inspection #696201937 documented that cement waste was spilled onto approximately 0.11 acres of the surface north of the Location in violation of Rule 1002.f.(2)B. Inspection required Operator to clean or remove impacted soils by 11/30/2020. Due to limited visibility from snow cover, Reclamation Specialist was unable to accurately determine if the corrective action has been addressed; no resolution documentation or records have been submitted by the Operator to show that the corrective action has been addressed, therefore the original corrective action and date will remain applicable; A followup inspection will be conducted to determine compliance with COGCC Stormwater Rules.</p> <p>It was observed in this inspection that Operator has "pot-holed" the access road; soil piles resulting from this operation have been left loose and unstabilized, and is considered a pollutant source; offsite sediment transport and erosion from the soil piles evident.</p>	trujilloam	03/04/2022
