Comment: Initial Form 19 was submitted on October 3, 2021 for a spill associated with an accident and fire. Supplemental Form 19 (Doc #402840887) submitted on 10/31/2021 had the following COAs:Removed closure request. Operator will address the following and submit another Form 19 Supplemental Report:1. The laboratory did not report results for 1,2,3-trimethylbenzene or 1,2,4- trimethylbenzene.2. Magpie has reported a depth to water of 12 feet. Concentrations of 1- methylnaphthalene, 2-methylnaphthalene, and naphthalene exceed the Table 915-1 Groundwater SSLs at sample location SS-1.3. Clarify sample naming convention (e.g. SS-1-1:SS-1-2, etc.)Site inspection found no indication of E&P waste remaining on location.

Corrective Action: Pursuant to Rule 912.b.(6) Operator was required to submit a Form 19 Supplemental Report for the associated spill within 90 days of the spill date requesting closure. The Form 19 Supplemental Report for closure was due by January 1, 2022. Operator shall comply with COAs on Document #402840887 and Rule 912.b.(6).
