While there, I observed master valve leaks and stained soil on location. During this inspection the following possible compliance issues were observed: Rule 608.e. with a corrective action date of 5/13/2022, Rule 905.e. with a corrective action date of 5/13/2022. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
