General Comment:

On 5/13/2022 Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

-Stormwater and erosion controls on the access road are not adequate. Cobble placement, turnouts, and wattles are not installed using good engineering principles resulting in accelerated erosion and sedimentation along the access road. Grading and regrading erosional features is not a stabilization measure.

Install stormwater BMPs and stabilization measures along the access road to reduce erosion and stabilize road surfaces, ditches, and turnouts. Corrective action back-dated to 2021 corrective action date (9/15/2021) for potential enforcement purposes. Stormwater erosion along the access road is an ongoing issue here and needs to be addressed immediately using good engineering practices.
