Comment:

Records show well PA 7/3/2014; pursuant to 1004.a, reclamation work required to be completed by 7/3/2015
 It was observed in this inspection that Final Reclamation has not been conducted in accordance with COGCC 1004 requirements; Reclamation at the access road including, but not limited to, removal of culverts, recontouring/regrading has not been conducted.

Operator has only recontoured/reclaimed the Location, and 600 feet of access road leaving south from the Location; reclaimed section of access road appears to meet 1004 revegetation standards. Though shrub establishment is evident throughout the site, the Location remains predominantly bare with undesirable plant and noxious weeds species such as annual wheatgrass and Halogeton.

Corrective Action:

Comply with 1004.a and conduct final reclamation at the access road, and areas of the Location not progressing towards 1004 revegetation standards. At a minimum, recontouring/regrading activities at access road is required to be completed by 7/31/2022. To allow for a fall seeding, revegetation activities are required no later than 11/15/2022. Operator shall ensure temporary control measures are implemented and maintained until revegetation activities are conducted, at which point controls to stabilize the seeded soils are required; Operator shall maintain stormwater and erosion control measures until site receives a passing final inspection.
