Comment

Russian knapweed (List B Noxious Weed) was observed at the northeast and southwest of the Location.

Interim areas of the Location appear to have been seeded with the non-native perennial grasses crested wheatgrass and smooth brome which are fairly uniformly established. The undesirable plant species kochia and Russian thistle are present. At the time of this inspection undesirable plant species are not forming dense monocultures which can interfere with perennial plant establishment in the interim areas.

Corrective Action

Conduct weed management to prevent further establishment and spread of List B Noxious Weeds. Ongoing weed management is required until location passes final reclamation.
