Comment:

This location does not meet reclamation requirements. Perennial cover is not uniform. There are areas throughout the Location, especially to the northwest where bare ground is common. Noxious and undesirable weeds are common (Refer to the "Location" section of this inspection report for weed control corrective action). Access road is unreclaimed, soils are highly compacted and the road is completely colonized by Kochia, an annual undesirable weed, with no perennial establishment.

These issues were previously identified in inspection #692402480 and #692403501. It does not appear they have been addressed.

Corrective Action:

Conduct additional reclamation in accordance with COGCC 1000 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 11/15/2022.
