Comment: The portion of the access road is swaled and not recontoured. There are compacted soils along the access road. The location and battery site have been recontoured and soils appear to be decompacted. The pipe risers have been removed. Reclamation has not been completed and it was communicated that seeding was planned to be performed in the upcoming fall season. Previous corrective action has not been completed. The location remains out of compliance until reclamation is completed.

Operator must consult the surface owner regarding fencing of the well site and in preparation of reclamation. All disturbed areas must be recontoured, properly decompacted by cross ripping to a depth of 18 inches, have an adequate seedbed prepared, and then seeded with a seed mixture that reflects the surrounding vegetation as agreed upon with the surface owner and as prescribed by the local soil conservation district. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of predisturbance or reference area levels. Continue to monitor and manage this site until Final Reclamation has Passed	CostaR	08/12/2022
The one wire electric fence around the location is inadequate to prevent livestock entry. The electric wire twisted to the wood post will make the electric wire deficient. All fencing is to be performed per landowner request.	CostaR	08/12/2022
