Comment

There are noxious weeds along the access road and at the location. Observed Musk thistle, Scotch thistle, and Mullein. There are signs of previous weed control which was not effective and weeds have now produced seed heads which should be cut, bagged, and removed. It is recommended that the operator consult with the local weed control agency or other weed control authority when weed infestation occurs. It is the responsibility of the operator to monitor affected and reclaimed lands for noxious weed infestations. Corrective action needs to be performed immediately.
