Comment Overall status of interim reclamation on the Location is in process. Original cut slopes on the south end of the Location remain evident; additional contouring efforts will necessary to address cuts slopes of the Location during final reclamation. Desirable perennial vegetative establishment progressing towards 1003 standards on remaining interim areas.

CO List B Noxious weeds observed throughout the interim areas, cut/fill slopes and within stormwater BMPs at the northern edge of the Location. Some weeds appear to have been treated, but many are untreated. Species include houndstongue, plumeless and Canada thistle and Russian olive.

Corrective Action Comply with Rule 606/1003.f. Conduct weed management to prevent further establishment and spread of Noxious Weeds. Any dead weeds left are considered debris and require removal in accordance with 606 rules. Ongoing weed management required.

Comment: Previous inspections #696203426 #696203320 and #700703067 observed that control measures to stabilize the production areas of the Location were missing or insufficient. Inspection required Operator to install or repair required BMPs by 9/3/2021.

It was observed in this inspection that control measures to protect and stabilize the production areas remain missing or insufficient; gravel is present at the west of the production area, but the eastern production area remains unstabilized. Tracking and degradation is evident. Original corrective action remains applicable.
