<p>There is a remediation project #19874 currently in process at the location. The location should have been reclaimed within 12 months of abandonment. The location has been recontoured since the previous inspection. Soils were ripped in one direction leaving areas of soil still compacted. Soils must be cross ripped to a depth of 18 inches and adequately tilled. Reclamation and seeding should be completed by the upcoming fall season. The location remains out of compliance until reclamation is completed. The one wire fence around the location is inadequate to prevent livestock entry.</p>		Date _____

<p>Comment: There is no indication that Enervest Operation performed road maintenance. The other operator submitted documentation of road maintenance. Any vehicle/equipment damage to the road will need to be repaired and stabilized. It is still a concern that stormwater may pool along low areas of the road. The access road will need to be maintained.</p> <p>There are no down gradient stormwater BMP's installed to prevent sediment from moving offsite. The soils at the location are not stabilized and are susceptible to erosion. Previous corrective action was not completed. Corrective action needs to be performed immediately.</p>
