Reclamation has not been completed and it was communicated that seeding was planned to be performed in the upcoming fall season. The powerline is supposedly active for the facility located to the northeast. The powerline should be relocated to the active facility. Previous corrective action has not been completed. The location remains out of compliance until reclamation is completed.
