Comment: **This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 11/24/2018. It appears reclamation work has been performed; the final land use is now a golf course. During this inspection, COGCC Staff observed a List B Colorado Noxious Weed (Canada Thistle) throughout the location, in addition to other annual weedy vegetation (Russian Thistle). Refer to attached inspection photos.**

Corrective Action:	Comply with Rule 1004. Operator shall manage weedy vegetation on location. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.	Date	10/31/2022
