	<p>This location does not comply with Rule 1004. There appears to be an approximate 200 foot section of flowline where crop growth is not reflective of reference areas. Based on historic aerial imagery from 2016, there may have been previous vegetative issues associated with the flowline area.</p> <p>The associated offsite tank battery is not within crop production and there were no noxious weeds observed.</p>	
Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
