Comment: It was observed in this inspection that this Location has not been reclaimed. Cut/fill slopes, a flat, graveled, compacted pad and three former pits are present and unreclaimed. Canada thistle and mullein (noxious weeds) were present.

The Location access road is a main State Land Board access road. Reclamation of the road not necessary.

Corrective Action:	Comply with 1004 Rules. Conduct final reclamation including, but not limited to: equipment/waste/debris removal, gravel removal, compaction alleviation (cross ripping to a minimum depth of 18 inches), recontouring/regrading, replacement of topsoil, and revegetation activities on the Location including pits; use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district. Implement control measures to stabilize the seeded soil in accordance with Rule 1002.f.(2)C. Revegetation activities shall be completed no later than 5/1/2023.	Date	05/01/2023
