There was recent weed control performed at the location. Many of the weeds have already gone to seed and ongoing weed control will be required. It was observed that weed treatment was occurring on native desirable plants. Operator should consult with contractor as to what is being sprayed. There are also areas of the interim reclamation area where noxious weeds have not been controlled. Since the growing season is coming to an end ongoing weed control will need to be conducted more thoroughly next spring.
