On 11/16/2022, Reclamation Specialist O'Malley conducted a reclamation and stormwater inspection at Beeman Oil & Gas LLC's Welker 6-92 /1-2H11 Location #438580 in Moffat County, Colorado.

Previous inspection documents # 702800198, # 702800491 and # 700704628 have multiple corrective actions that have not been addressed.

The following compliance issues were observed during this inspection:

- Safety labeling is missing/insufficient
- Trash/debris
- Weed debris
- Stained soils
- Wildlife protection BMP's missing/insufficient
- Plastic tote not contained
- Workover rig on location no form 42 on file for move in/rig up
- Dead men lacking markers or not properly marked
- Noxious weeds

Comment It was observed in this inspection that noxious weeds are widespread on the Location. Mature plants have gone to seed and are acting as a seed source. First year thistle rosettes are widespread. Species observed include scotch and Canada thistle, cheatgrass, houndstongue and spotted and diffuse knapweed. It does not appear that weed management has been performed. Original corrective action and date fom inspection #702800198 remain applicable. Weed management required in the 2023 growing season.

After review of this location with Enforcement, it was determined that per Approved Variance document #401291912, interim reclamation is required by 11/15/2023.

Corrective Action Comply with Rule 1003.f and conduct weed management on the Location to prevent further establishment and spread of CO State List B Noxious Weeds; ongoing weed management required.
