COGCC Inspection Report Summary
 On Thursday 11/17/2022 at approximately 1200, I, Inspector Scott Ramsey, conducted a routine inspection for P/A operations at Crow heart energy Landing Strip Federal 1, at Location # 313308 in Moffet county Colorado.
 Any Corrective Actions from previous Inspections that have not been addressed are still applicable.
 While there, I observed the start of P/A operations. The rig was setting up. Company man informed that the well had approx. 1200 PSI at the start, blew down and had production water retuning. They were waiting for 9 pound mud to show up to kill well. This location is within or in close proximity to a CPW sensitive Wildlife Habitat, Elk winter concentration, NSO habitat, Wildlife Management and Federal land.
 During this inspection the following compliance issues were observed:
 1. Random debris and stored equipment.
 2. Lack of stabilization on cut slope and erosion

 A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
