Laboratory analytical indicated a historical release occurred along the Spike St CC30-13 decommissioned flowline. One soil sample exceeded COGCC standards for benzo(a)anthracene at 0.134 mg/kg, benzo(a)pyrene at 0.467 mg/kg, 1-methylnaphthalene at 0.0274 mg/kg, and 2-methylnaphthalene at 0.0418 mg/kg.
