Comment:	It was observed in this inspection that the Location shows signs of lack of stabilization BMPs in some areas, as is evidenced by the presence of ruts. In particular degradation of the pad surface was observed at the separator pad and at the entrance to the well pad. Tracking control BMPs to minimize/mitigate tracking and offsite sediment transport are missing or insufficient.
