Operator Comment: COGCC Inspector A. Trujillo inspected this location on 11/21/22. TEP was notified by email of this corrective action on 11/22/22. On the same day of the notification (11/22/22), TEP Construction Superintendent (E. Dekam) replied to Mr. Trujillo that TEP has been attempting to apply hydro-mulch to the topsoil stockpile area over the last several days, but due to unseasonably cold temperatures in the area, the hydro-mulch pump / lines were freezing up and were not functioning correctly. Crews were finally able to complete the hydro-mulch operations on the stockpile on 11/23/22. Photos of the mulched soil stockpile are attached. Erosion control wattles have also been installed around the perimeter of the top soil stockpile area as a BMP to contain and control sediment migrating from the stockpile. This corrective action has been completed.

The top soil stockpile area was successfully hydro-mulched on 11/23/22 to stabilize the salvaged top soil and protect the soil from wind and water erosion. Erosion control wattles have also been installed around the perimeter of the top soil stockpile area as a BMP to contain and control sediment migrating from the stockpiles.
