	<p>The well location appears to meet final reclamation regulations and standards, and appears reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.</p> <p>The tank battery location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged on 1/11/2017. Tank battery has a large pile of dirt in the middle of the disturbance and northern access road remains unreclaimed with gravel.</p>
