**General Comment:**[COGCC Inspection Report Summary](#)

On Wednesday, 03/01/2023, Inspector Kirby Burchett, started to conduct a routine field inspection at KT Resources on the FEE-62N96W 31SWSW Location, Location #336391, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District including High Priority/NSO/Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there, I found both wells in state of Temporary Abandonment.

Both wells are overdue for Mechanical Integrity Test (MIT) MIT require 10 day notification via Form 42. Well plugging requires an approved Form 6 Intent to Abandon to plug well. Well can only be returned to SI status if it has produced (without mechanic intervention) within 2 years.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
