	Operator shall field screen the four sidewalls and the 4 quadrants of the bottom hole. A soil sample will be taken at the location with the highest field screening/PID reading. Collect confirmation soil samples as described in the Rule 915.e.(2). Operator will analyze soil samples for TPH (C6-C36), Table 915-1 Organic Compounds in Soil, Table 915-1 metals, and Table 915-1 Soil Suitability for Reclamation (Electrical conductivity, Sodium adsorption ratio, and pH by saturated paste method, boron (hot water soluble)).
	The surface area disturbed by site investigation and decommissioning activities shall be reclaimed in accordance with the 1000 Series Reclamation Rules. For locations that will no longer have active oil and gas operations, Operator shall comply with Rule 1004 Final Reclamation requirements. Note: Approval of this form does not imply approval of Operator's proposed plan for reclamation.
