During this inspection the following possible compliance issues were observed: Trash: Rule 606 Corrective action date of 3-31-23 See photo 6 Debris: Rule 606 Corrective action date of 3-31-23 See photos 6,7 Weather conditions: Clear I spoke with onsite foreman and welder at time of inspection. When I drove up on location welder was in open excavation. I ask what they were doing Welder stated going to install 3" Transition to attach 3" SDR 11 poly line. I ask to see monitor, hot work permit and asked about JSA. Crew had not filled out said documents. I informed crew until a gas monitor and proper paper work was filled out I was doing a safety shut down. Approx. 15 later Crew supervisor arrived of site with monitor and paper was filled of and signed. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
