On 4/3/2023 at approximately 11:40, Compliance Inspector Matthew Morris conducted an on-site inspection at LARAMIE ENERGY LLC, OXY Federal/23-15 Pad at Location ID #324268 in Garfield County, Colorado.

Normal production operations were observed.

During the inspection, the following compliance issues were observed:

- 1) Site degradation from snow plow causing transport of sediment and lack of stabilization
- 2) Lease road degradation from snow plow causing transport of sediment and lack of stabilization
- 3) Inadequate tracking BMP to minimize sediment migration on location and lease road

Unable to inspect all BMPs due to snow cover

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
