Comment:

This location does not comply with Rule 1004. Previous inspections (Doc #682504339, 682503009, and 675103784) documented that the access road had not been reclaimed and equipment (e.g. pipe risers) remain on location. At the time of this inspection, Staff observed that pipe risers remain, debris (e.g. straw wattles) are still installed on slopes, and undesirable vegetation (e.g. CO List C Noxious weed-cheatgrass) are evident throughout the reclaimed portion. Further reclamation activities are require for this location. Refer to attached inspection photos.

Corrective Action: **Comply with Rule 1004. Corrective action date is being backdated to when the location was observed out of compliance.**
