An excavation was conducted to remove impacted soil above COGCC Table 910-1 standards in September 2017.

A propane-powered air sparge system has been installed and is operational. Three passive soil vapor extraction wells have also been installed. The remediation system was shut down before the October 2022 groundwater monitoring event to monitor groundwater quality under natural conditions and has remained off. An NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits under static conditions. As needed, soil and/or groundwater remediation plans will be developed and submitted to COGCC in a supplemental Form 27.

GROUNDWATER MONITORING

Groundwater will be sampled on a quarterly basis until analytical results are reported with concentrations Table 915-1 analytes below regulatory limits for four consecutive quarters. Eight monitoring wells (MW-1, MW-2RR, MW-3 through MW-6, MW-7R, and MW-8R) are sampled on a quarterly basis to monitor attenuation. Monitoring wells MW-1, MW-2R, MW-3R, MW-4, MW-5, and MW-6 had insufficient water to collect a groundwater sample during the Q2 2023 groundwater sampling event on 4/26/2023. Monitoring well MW-7R had insufficient water to analyze for inorganic constituents in groundwater. Groundwater monitoring wells were sampled and submitted to a laboratory for analysis of Table 915-1 groundwater constituents: Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS).
