This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.</p> <p>C/A (battery signage) from previous inspection document #'s 699803973 and 699804394 has been completed.</p> <p>During this inspection the following compliance issues were observed: 1. Chemical containment full of fluid not sufficient to contain possible spill 2. Stored equipment on location has staining under equipment and next to it. Refer to photograph of observed compliance issue.</p> <p>A follow up on this site inspection may be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
