The well was SI at the time of inspection. The following was observed. Pumping unit on a wooden pyre. Well has a three wire fence around it. Flowlines: there is a shallow buried line from the wellhead to tank, There is a second flowline that is sitting on the surface and head off into the hay meadow to the south. There is a 200bbl tank that has NO secondary containment. This was documented on Inspection 707800360, 5/12/23 and inspection going back to at least 2010, doc 200290324. See attached Photos.
