Comment:

The Location ID (333155) is still active for another Operator (PDC). This inspection is only for the Lundvall well location and associated off location tank battery and does not address anything related to PDC.

The well location (cropland) and associated off location tank battery (non-cropland) meet final reclamation regulations and standards. Unable to find evidence of oil and gas activities and/or disturbances. The location and associated disturbances are reflective of reference areas.

Final Reclamation cannot be approved at this time due to an unresolved NOAV regarding off-location flowlines and failing to submit off-location abandonment requirements. Once a resolution has been approved, then Final Reclamation can be passed.
