COGCC Inspection Report Summary

**Weather Conditions: partly cloudy, dry ground

On Thursday, October 12, 2023 at approximately 1000, I, Inspector Brittani Santistevan, conducted an on-site inspection at HSR-CAMP 4-31 X (Kerr McGee Oil & Gas Onshore), at location #: 329196 in Weld County, Colorado.

While there, I observed a plugged and abandoned wellhead.

During this inspection the following possible compliance issues were observed:

1. It appears that the gas meter still remains on location. Any and all surface equipment on location is the operator's responsibility to have it removed from location when it is no longer in use. Comply with Rule 1004.a. (Corrective Action Date: November 12, 2023) See attached photo #4.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
