Gentlemen:

We have contacted you several times in the past relative to the status of the Banker-Robinson Ranch #1 well, Lot 10, Section 12, Township 1 North, Range 103 West, Rio Blanco County, Colorado.

We should like very much to have you advise us of the status of this well, as well as your future plans for operation. Besides the fact that several times in the past the bonding company has asked us for cancellation of the bond, one of our rules provides that completion reports be filed within 30 days after the completion of any well - completion meaning either the running of pipe preparatory to producing, or plugging. Maximum penalty for violation of our rules and regulations is \$1000 per violation and \$1000 per day while in violation.

We solicit your prompt cooperation in this matter, and shall anticipate an answer from you at an early date.

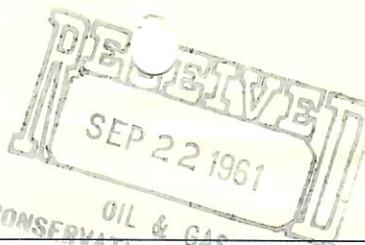


Gentlemen:

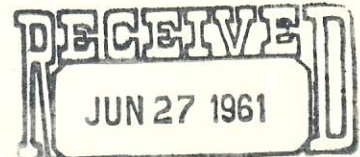
