While there, I observed a shut in facility and temporarily abandoned wellhead. During this inspection the following possible compliance issues were observed: 1. It appears that the operator name is no longer visible on the wellhead signage. Install sign to comply with Rule 605g. (Corrective Action Date: January 6, 2023) See attached photo #5.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
