1. Signs/Marker - Wellheads lack required signage with a CA date of 01/10/2024
2. Signs/Marker - Tank label damaged/missing required information with a CA date of 01/10/2024
3. Housekeeping - Unused equipment on location with a CA date of 01/10/2024
4. Equipment - Open ended piping/wildlife hazards with a CA date of 12/18/2023
