INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

On May 28, 1962, pulled rods and tubing. Checked PBTD at 5064'. Dumped 250 gal MCA down casing. Broke down 1800 psi, pumping into formation. Sand fraced w/ 7600# 20-40 mesh sand and 400# 10-20 mesh sand using crude oil as carrier. Used 20 RCN balls. Breakdown pressure 1800 psi. Maximum pressure 1900 psi. Minimum pressure 1600 psi. ISIP 1900 to 900 psi, on vacuum in 5 minutes. Average injection rate 17.6 BPM. Checked PBTD, placed well on pump.

Production before workover: 39 BOPD, 2 BWPD  
 Production after workover (10 day average): 44 BOPD, 3 BWPD

NOTE: Above work was done on the Dakota "D" interval 4960-4970'.
