INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A desktop review shows that there are 3 permitted water wells, all clustered in a small area southwest of the Stroh O 2-17 well and within 1/4 mile. According to DWR documents, the 3 well depths are listed as 35', 25', and 42'. The bottom of the alluvium/top of the Laramie Fox Hills is estimated to be ~40'. Pending landowner permission, Noble initially proposed to sample the deepest water well (receipt 9063380, depth 42') since this is on-dip and appears to be in the Laramie Fox Hills. The other two wells (receipt 9064634 and 3600613) would be backup options in the event that receipt 9063380 is not accessible. During on site investigations and outreach to landowners, it was determined that the proposed water wells as shown on the desktop review, no longer exist and are not viable sampling options. Noble installed a shallow monitoring well on October 3, 2023 adjacent to the Stroh O 2-17 and collected groundwater samples from the monitoring well.

Noble collected groundwater samples from the new monitoring water well that was installed as described above. Samples were analyzed for Rule 615 constituents. Methane was not detected according to the laboratory report; therefore, isotopic analysis was not performed.
