Comment: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 12/18/2019. During this inspection, it was observed that debris (e.g. degraded straw wattles) remain on location, undesirable vegetation (e.g. russian thistle and kochia) was present and the location does not appear to have been contoured to reflect adjacent topography. Additional reclamation activities are required. Refer to attached inspection photos.

Corrective Action:	Comply with Rule 1004. Perform reclamation activities and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.	Date	04/30/2024
