Operator has not been able to find a location close to wellhead or to off location meter shed to indicate location of a produced water pit. There is no visible indentation or reduced or no growth of crops at wellhead or off site meter shed location. Operator feels that a Form 15 is not viable due to not knowing of a new location of pit and submitting inaccurate information to ECMC. Operator requests Rule to identify equipment not located on oil and gas location that is not owned and/or operated by operator.
