APPLICATION

Extraction Oil & Gas, LLC ("Extraction" or "Applicant"), Operator No. 10459, by its attorneys, Welborn Sullivan Meck & Tooley, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission" or "COGCC") for an order vacating Order No. 407-1775 and pooling all interests in two approximate 800-acre wellbore spacing units ("WSU") established for the W½W½ of Sections 1 and 12, the E½E½ of Sections 2 and 11, the W½NW¼ of Section 13, and E½NE¼ of Section 14, Township 5 North, Range 66 West, 6th P.M., Weld County, Colorado for the development and production of oil, gas and associated hydrocarbons from the Codell Formation in WSU No. 1 and the Niobrara Formation in WSU No. 2. In support thereof, the Applicant states as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado.
- 2. Applicant owns a leasehold interest in the following lands ("Application Lands"):

Township 5 North, Range 66 West, 6th P.M.

Section 1: W½W½
Section 2: E½E½
Section 11: E½E½
Section 12: W½W½
Section 13: W½NW¼
Section 14: E½NE¼

Weld County, Colorado.

A reference map of the Application Lands is attached hereto.

3. Rule 318A.a.(4)D. provides, in relevant part, that where a drilling and spacing unit does not exist for a horizontal well, the horizontal wellbore spacing unit shall be comprised of

the governmental quarter-quarter sections in which the wellbore lateral penetrates the productive formation as well as any governmental quarter-quarter sections that are located less than four hundred sixty (460) feet from the portion of the wellbore lateral that penetrates the productive zone regardless of section or quarter section lines. Rule 318A.a.(4)D. further provides that a horizontal wellbore spacing unit may overlap portions of another horizontal wellbore spacing unit or other wellbore spacing unit designated in accordance with subsection a.(4)C. The Application Lands are subject to this Rule.

- 4. On August 29, 2016, the Commission entered Order No. 407-1775, which, among other things, pooled all interests in two 720-acre horizontal wellbore spacing units For the Codell and Niobrara Formations and subject all nonconsenting interests to the cost recovery provisions of Section 34-60-116(7), C.R.S., for the CS-Bittersweet C1-1-13 well (API No. 05-123-42936) and the CS-Bittersweet 3-1-13 well (API No. 05-123-42937). Portions of the Application Lands are subject to this Order.
- 5. The CS-Bittersweet C1-1-13 and CS-Bittersweet 3-1-13 wells were initially proposed and permitted as 2-mile horizontal wells within two 720-acre Rule 318A horizontal wellbore spacing units. Applicant has re-proposed these wells to interested parties as 2.5-mile horizontal wells within two 800-acre Rule 318A horizontal wellbore spacing units, which are the subject of this Application. No objections were received. Applicant's Form 4 Sundry Notices to update the Form 2 Applications to Drill to reflect the longer lateral length consistent with the new well proposals have been approved by Commission staff. Accordingly, Applicant requests that Order No. 407-1775 be vacated.
- 6. Applicant plans to drill and complete the CS-Bittersweet C1-1-13 well within an individual wellbore spacing unit covering the Applications Lands in 3rd Quarter 2017, to produce oil, gas and associated hydrocarbons from the Codell Formation ("WSU No. 1") and the CS-Bittersweet 3-1-13 well within an individual wellbore spacing unit covering the Applications Lands in 3rd Quarter 2017, to produce oil, gas and associated hydrocarbons from the Niobrara Formation ("WSU No. 2"). Hereinafter, the "Wells."
- 7. Pursuant to the relevant provisions of Section 34-60-116(6) & (7), C.R.S., and COGCC Rule 530, Applicant seeks an order pooling all interests in the Application Lands for the development and operation of the Codell Formation in WSU No. 1 and the Niobrara Formation in WSU No. 2.
- 8. Applicant certifies that, at least thirty-five (35) days prior to the date of the scheduled protest deadline for this Application, each owner which Applicant was able to locate, not already leased or voluntarily pooled, has been provided with the well proposals and information required by Rule 530 and tendered a reasonable offer to lease (if an unleased mineral owner), or participate and bear costs associated with the drilling and completion of the Wells.
- 9. Applicant requests that a pooling order be entered as a result of this Application and that it be made effective as of the earlier of the date of this Application, or the date costs specified in Section 34-60-116(7)(b)(II), C.R.S., are first incurred for the drilling of the wells in the Codell Formation in WSU No. 1 and the Niobrara Formation in WSU No. 2.

- 10. The granting of this Application would be in accord with the Oil and Gas Conservation Act, found at Section 34-60-101, *et seq.*, C.R.S., and Commission rules.
- 11. The names and addresses of the interested parties (persons who own an interest in the mineral estate of the tracts to be pooled, except owners of overriding royalty interest) are attached hereto and marked Exhibit A. Applicant certifies that copies of this Application will be served on all locatable interested parties within seven (7) days of the date hereof, as required by Commission Rule 507.b.(2).

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing this Commission enter its order:

- A. Vacating Order No. 407-1775;
- B. Pooling all interests in the Application Lands for the development and operation of the Codell Formation in WSU No. 1 and the Niobrara Formation in WSU No. 2;
- C. Providing that the pooling order is made effective as of the date of this Application, or the date that the costs specified in Section 34-60-116(7)(b)(II), C.R.S., are first incurred for the drilling of a well in the Codell Formation in WSU No. 1 and the Niobrara Formation in WSU No. 2, on the Application Lands, whichever is earlier;
- D. Providing that the interests of any owners, with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the authorized wells, are pooled by operation of statute, pursuant to Section 34-60-116(7), C.R.S., and made subject to the cost recovery provisions thereof; and
- E. For such other findings and orders as the Commission may deem proper or advisable in the premises.


