AND 1 SOUTH, RANGE 68 WEST, 6TH P.M., WATTENBERG FIELD, BROOMFIELD AND WELD COUNTIES, COLORADO.

APPLICATION

Extraction Oil & Gas, Inc. ("Applicant"), Operator No. 10459, by and through its attorneys, Welborn Sullivan Meck & Tooley, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order to allow additional horizontal wells within two drilling and spacing units and to establish well location rules applicable to the drilling of wells and producing of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations covering certain lands in Broomfield and Weld Counties, Colorado. In support of its Application, Applicant states as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado, and is a registered operator in good standing with the Commission.
2. Applicant owns leasehold interest and/or the right to drill and is an Owner as defined by Commission rules, in the following lands:

Township 1 North, Range 68 West, 6th P.M.
Section 31: S1/2S1/2, S1/2N1/2S1/2
Section 32: SW1/4SW1/4, S1/2NW1/4SW1/4

Township 1 South, Range 68 West, 6th P.M.
Section 6: All

Section 7: N½

DSU No. 2

Township 1 South, Range 68 West, 6th P.M.

Section 7: S½

Section 18: All

Section 19: All

A reference map of the above-described lands is attached hereto.

3. On April 27, 1988, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule, which was amended on August 8, 2011 to, among other things, address the drilling of horizontal wells and requires that a horizontal wellbore spacing unit must include any governmental quarter-quarter section that are located less than 460' from the completed interval of the wellbore lateral. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of the Greater Wattenberg Area.

4. On or about August 31, 2017, Applicant filed a verified amended application at Docket No. 170900596, for an order to establish an approximate 1,260-acre drilling and spacing unit for the S½S½ and S½N½S½ of Section 31, the SW¼SW¼ and S½NW¼SW¼ of Section 32, Township 1 North, Range 68 West, 6th P.M., and Section 6 and the N½ of Section 7, Township 1 South, Range 68 West, 6th P.M. for the development of the Codell and Niobrara Formations with the treated interval of the wellbore to be located no closer than 460 feet from the eastern and western unit boundaries and 150 feet from the northern and southern unit boundaries, without exception being granted by the Director ("DSU No. 1"). DSU No. 1 is currently scheduled to be heard at the October hearing of the Commission.

5. On or about August 31, 2017, Applicant filed a verified amended application at Docket No. 170900598, for an order to establish an approximate 1,600-acre drilling and spacing unit for the S½ of Section 7, and all of Sections 18 and 19, Township 1 South, Range 68 West, 6th P.M. for the development of the Codell and Niobrara Formations with the treated interval of the wellbore to be located no closer than 460 feet from the southern, eastern and western unit boundaries and 150 feet from the northern unit boundary, without exception being granted by the Director ("DSU No. 2"). DSU No. 2 is currently scheduled to be heard at the October hearing of the Commission.

6. To promote efficient drainage of the Codell and Niobrara Formation within the Application Lands and to avoid waste, Applicant requests that the Commission amend orders issued in Docket No. 170900596 and 170900598 to allow an additional nineteen horizontal wells for a total of twenty (20) horizontal wells within the drilling and

spacing units covering the lands described below as DSU No. 1 and DSU No. 2 for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations:

7. Applicant is requesting to drill and complete one (1) horizontal well in the drilling and spacing units described above, with the option to drill and complete up to a total of twenty (20) horizontal wells in the unit for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations. Applicant further requests that the well location rules established in orders issued in Docket No. 170900596 and 170900598 control, and that, for DSU No. 1, the treated interval of each wellbore be no closer than 460 feet from the eastern and western unit boundaries, and no closer than 150 feet from the northern and southern boundaries, and that, for DSU No. 2, the treated interval of each wellbore be no closer than 460 feet from the southern, eastern, and western boundaries, and no closer than 150 feet from the northern unit boundary. Applicant further requests that the wells be no closer than 150 feet from the productive interval of any other wellbore located within the Codell and/or Niobrara Formations in the drilling and spacing unit, unless an exception is granted by the Director.

8. Applicant requests authority to drill only those wells necessary to determine the well density which allows the most efficient drainage of the Codell and Niobrara Formations, prevents waste, does not adversely affect correlative rights, and assures the greatest ultimate recovery of oil, gas and associated hydrocarbon substances from the Codell and Niobrara Formations. The proposed additional wells will not result in DSU No. 1 or DSU No. 2 becoming smaller than the maximum area that can be economically and efficiently drained by the proposed wells in such drilling and spacing unit. Applicant further maintains that wells drilled in the drilling and spacing unit will have no adverse effect on correlative rights of adjacent owners.

9. Applicant states that the wells will be drilled from no more than one (1) well pad within each unit or from a legal location on adjacent lands, without exception being granted by the Director.

10. The names and addresses of the interested parties according to the information and belief of the Applicant are set forth in Exhibit A attached hereto and made a part hereof, and the undersigned certifies that copies of this Application shall be served on each interested party within seven (7) days after filing of the Application as required by Rules 503.e., 507.b.(1), and 507.c.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that, upon such hearing, this Commission enter its order consistent with Applicant's proposals as set forth above.

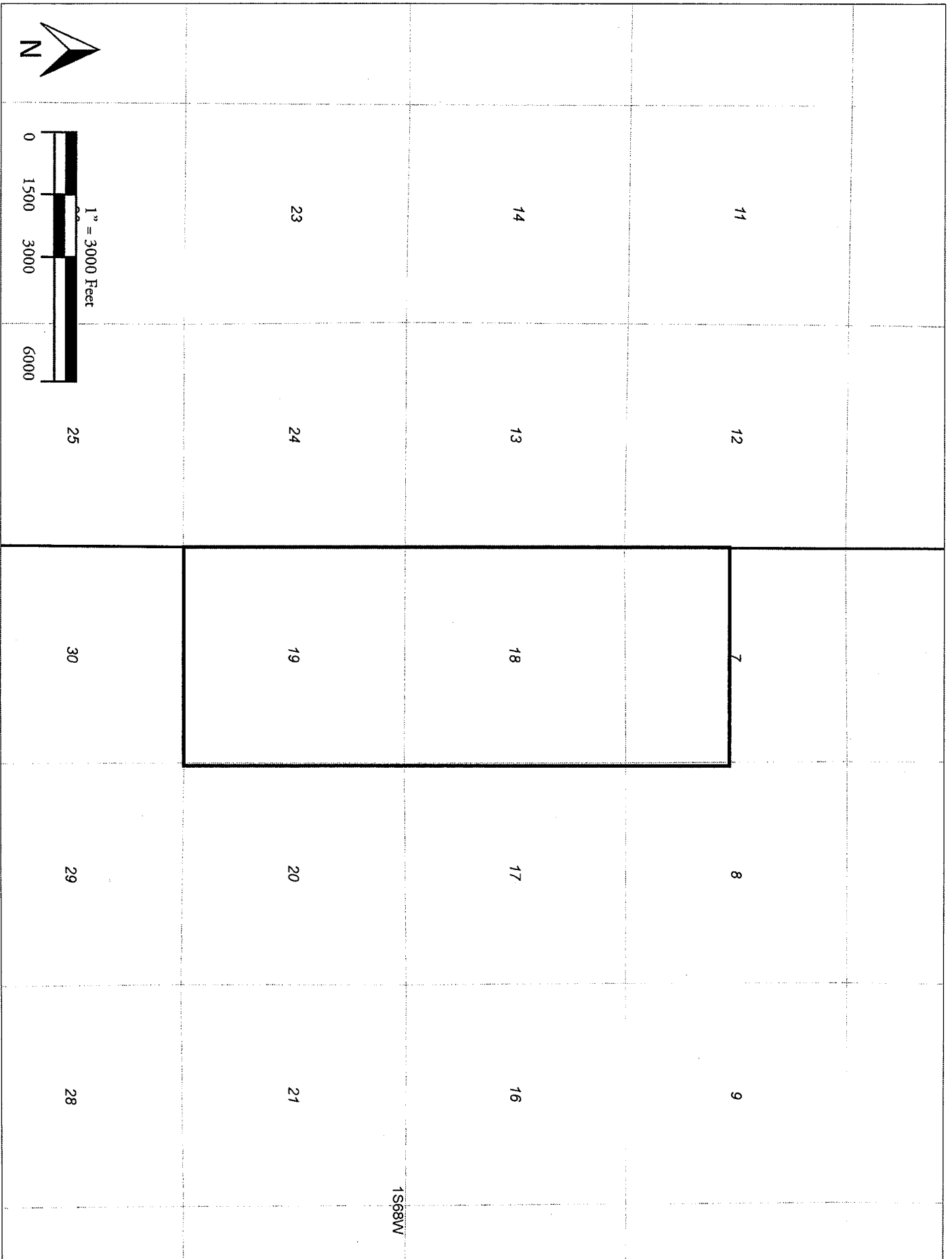
