**APPLICATION**

COMES NOW Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), by its attorneys, Jost Energy Law, P.C., and makes this application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order to pool all interests in 16 approximate 1,440-acre designated horizontal wellbore spacing units, as defined below, for the drilling of the following wells (API Nos. Pending): Postle IC 09-022HC in WSU #1; Postle IC 09-059HNX in WSU #2; Postle IC 09-059HN in WSU #3, Postle IC 09-099HN in WSU #4, Postle IC 09-099HC in WSU #5, Postle IC 09-102HNX in WSU #6, Postle IC 09-102HN in WSU #7, Postle IC 09-142HC in WSU #8, Postle IC 09-142HN in WSU #9, Postle IC 09-179HN in WSU #10, Postle IC 09-179HNX in WSU #11, Postle IC 09-182HC in WSU #12, Postle IC 09-219HN in WSU #13, Postle IC 09-222HN in WSU #14, Postle IC 09-222HNX in WSU #15, and the Postle IC 09-259HC in WSU #16 ("Wells"), for the development and operation of the Codell and Niobrara Formations on the following described lands:

Hereinafter "Application Lands."

In support thereof, Applicant states and alleges as follows:

1. Applicant is a limited liability company duly authorized to conduct business in the State of Colorado, and is a registered operator in good standing with the Commission.

2. Applicant and/or its affiliate company Grizzly Petroleum Company, LLC are Owners as defined by the Colorado Oil and Gas Conservation Act and the Commission's 100 Series Rules and own certain leasehold interests and/or the right to drill and produce on the Application Lands.

3. On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule. The Application Lands are subject to Rule 318A for the Codell and Niobrara Formations.

4. On February 19, 1992, the Commission entered Order No. 407-87 which established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations, within the permitted well locations in accordance with Order No. 407-1. The Application Lands are subject to this Order for the Codell and Niobrara Formations.

5. On January 29, 2018, the Commission entered Order No. 407-2324 which, among other things, pooled all interests in eight approximate 1,440-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara and Codell Formations, and subjected any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Postle IC 09-259HN in WSU #1 (API No. 05-123-46038), Postle IC 09-299HN in WSU #2 (API No. 05-123-46041), Postle IC 09-299HNX in WSU #3 (API No. 05-123-46040), Postle IC 09-302HC in WSU #4 (API No. 05-123-46043), Postle IC 09-302HN in WSU #5 (API No. 05-123-46044), Postle IC 09-342HN in WSU #6 (API No. 05-123-46039), Postle IC 09-342HNX in WSU #7 (API No. 05-123-46037) and Postle IC 09-379HC in WSU #8 (API No. 05-123-46042) to the Codell or Niobrara Formations.

6. Applicant designated the 16 approximate 1,440-acre designated wellbore spacing units, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations pursuant to Rule 318A and notified the appropriate parties under Rule 318A.

7. Applicant, pursuant to Commission Rule 530 and/or the provisions of C.R.S. § 34-60-116 (6) and (7), hereby requests an order to pool all interests, including but not limited to, any non-consenting interests, in the Application Lands in the Codell and Niobrara Formations underlying the 16 approximate 1,440-acre wellbore spacing units for the drilling, development and operation of the Wells.

8. Applicant certifies that copies of this Application will be served on all persons owning an interest in the mineral estate of the tracts to be pooled within seven (7) days of the date hereof, as required by Rule 503.e., and that at least thirty-five (35) days prior to the hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease, or to participate in the drilling of the respective Wells, and will be provided with the information required by Rule 530 as applicable.

9. That in order to prevent waste and to protect correlative rights, all interests in WSU #1, WSU #2, WSU #3, WSU #4, WSU #5, WSU #6, WSU #7, WSU #8, WSU #9, WSU #10, WSU #11, WSU #12, WSU #13, WSU #14, WSU #15 and WSU #16 should be pooled for the orderly development and operation of the Codell and Niobrara Formations, including any non-consenting interests therein.

10. The granting of this Application is in accord with the Oil and Gas Conservation Act, found at §§ 34-60-101 et seq., C.R.S., and the Commission Rules.

WHEREFORE, Applicant requests that this matter be set for hearing on April 30, 2018, that notice be given as required by law, and that upon such hearing, the Commission enter its order:

A. Pooling all interests in 16 approximate 1,440-acre designated horizontal wellbore spacing units on the below-described Application Lands for the development and operation of the Codell and Niobrara Formations:

B. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b) are first incurred for the drilling of each Well in WSU #1 - WSU #16 for the development of the Codell and Niobrara Formations on the Application Lands.

C. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Wells are pooled by operation of statute, pursuant to C.R.S. § 34-60-116(6) and (7), and made subject to the cost recovery provisions thereof with respect to the Wells drilled to develop the Codell and Niobrara Formations in the 16 approximate 1,440-acre designated Wellbore Spacing Units comprising the Application Lands.

D. For such other findings and orders as the Commission may deem proper or advisable in this matter.
