AMENDED APPLICATION

8 North, LLC ("8 North" or "Applicant"), Operator #10575, by and through its attorneys, Poulson, Odell & Peterson, LLC, respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission" or "COGCC") for an order: (1) modifying Order No. 535-59 to reduce the number of authorized wells to one horizontal well within the approximate 960-acre drilling and spacing unit established for the S¹/₂ of Section 25 and Section 36, Township 10 North, Range 60 West, 6th P.M., for production of oil, gas and associated hydrocarbons from the Niobrara Formation, and maintaining allocation of proceeds for any existing wells located within said unit and producing from the Niobrara Formation, (2) vacating the approximate 960-acre drilling and spacing unit established by Order No. 535-151 for Section 24 and the N1/2 of Section 25, Township 10 North, Range 60 West, 6th P.M., which authorized the drilling of four horizontal wells within each unit, for production of oil, gas and associated hydrocarbons from the Niobrara Formation, and (3) establishing an approximate 1,280-acre drilling and spacing unit for Sections 24 and 25, Township 10 North, Range 60 West, 6th P.M., and authorizing the drilling of 12 horizontal wells within the proposed unit, for production of oil, gas and associated hydrocarbons from the Codell, Fort Hays, Carlile, and Niobrara Formations. In support of this Application ("Application"), Applicant states and alleges as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado, and has registered as an operator with the COGCC.
- 2. Applicant owns substantial leasehold interests in the below-listed lands ("Application Lands"):

Township 10 North, Range 60 West, 6th P.M.

Section 24: All Section 25: All

3. COGCC Rule 318.a. provides that for any oil or gas well drilled to a common source of supply and drilled to a producing depth at least 2,500 feet below ground surface shall be located not less than 600 feet from any leaseline and not less than 1,200 feet from any other producing or drilling oil or

gas well when drilling to the same source of supply, unless authorized by Commission order upon hearing. Section 36, Township 10 North, Range 60 West, 6th P.M., and Section 1, Township 9 North, Range 60 West, 6th P.M., are subject to this Rule for production of oil and gas from the Codell, Fort Hays and Carlile Formations. The Fort Hays and Carlile Formations are non-target formations, however are included in the proposed drilling and spacing unit at the Commission's request in the event the horizontal wellbore of any permitted well under the approved Application deviates into these formations.

- 4. On August 8, 2011, the Commission issued Order No. 535-59 which, among other things, established an approximate 960-acre drilling and spacing unit for the S½ of Section 25, Township 10 North, Range 60 West, 6th P.M., and Section 36, Township 10 North, Range 60 West, 6th P.M., and authorized the drilling of four horizontal wells within said unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of any permitted well located no closer than 600 feet from the unit boundaries.
- 5. On March 5, 2012, the Commission issued Order No. 535-151 which, among other things, established an approximate 960-acre drilling and spacing unit for the N½ of Section 25, Township 10 North, Range 60 West, 6th P.M., and Section 24, Township 10 North, Range 60 West, 6th P.M., and authorized the drilling of four horizontal wells within said unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of any permitted well located no closer than 600 feet from the unit boundaries.

Modifying Order No.535-59 to reduce the number of authorized wells to one well within the approximate 960-acre drilling and spacing unit established for the S½ of Section 25 and Section 36, Township 10 North, Range 60 West, 6th P.M., for production from the Niobrara Formation

- 6. Applicant herein requests Order No. 535-59 be modified to reduce the number of authorized horizontal wells to one well for the approximate 960-acre drilling and spacing unit established for the S½ of Section 25 and Section 36, Township 10 North, Range 60 West, 6th P.M., for production of oil, gas and associated hydrocarbons from the Niobrara Formation. By modifying Order No. 535-59, Applicant will herein propose the establishment of an approximate 1,280-acre drilling and spacing unit for the Application Lands, with authority to drill 12 horizontal wells within the proposed unit, for production of oil, gas and associated hydrocarbons from the Codell, Fort Hays, Carlile, and Niobrara Formations. This proposed development plan will allow the drilling of 12 two-mile laterals running north-to-south or south-to-north within the proposed unit, thereby preventing waste while protecting correlative rights within the proposed unit area.
- 7. Whiting Oil & Gas Corp. presently operates the Church 36-2523H well ("Well"), API #05-123-33681, a horizontal well with its bottomhole located in the SW¼ NE¼ of Section 25, Township 10 North, Range 60 West, 6th P.M., and allocates production on a 960-acre unit basis under Order No. 535-59 for the S½ of Section 25 and Section 36, Township 10 North, Range 60 West, 6th P.M., for production of oil, gas and associated hydrocarbons from the Niobrara Formation. Applicant requests that allocation of proceeds from the Well be maintained and unaltered by the approved Application, for production of oil, gas and associated hydrocarbons from the Niobrara Formation.

<u>Vacating the approximate 960-acre drilling and spacing unit established for Section 24 and the N½ of Section 25, Township 10 North, Range 60 West, 6th P.M., for production from the Niobrara Formation</u>

8. Applicant herein requests the approximate 960-acre drilling and spacing unit established by Order No. 535-151 for Section 24 and the N½ of Section 25, Township 10 North, Range 60 West, 6th P.M., which authorized the drilling of 4 horizontal well within said unit, for production of oil, gas and associated hydrocarbons from the Niobrara Formation, be vacated. By vacating Order No. 535-151, Applicant will herein propose the establishment of an approximate 1,280-acre drilling and spacing unit for the Application Lands, with authority to drill 12 horizontal wells within the proposed unit, for production of oil, gas and associated hydrocarbons from the Codell, Fort Hays, Carlile, and Niobrara Formations. This proposed development plan will allow the drilling of 12 two-mile laterals running north-to-south or south-to-north within the proposed unit, thereby preventing waste while protecting correlative rights within the proposed unit area.

Establishment of an approximate 1,280-acre drilling and spacing unit for the Application Lands, for production from the Codell, Fort Hays, Carlile and Niobrara Formations

- 9. Applicant herein seeks the establishment of an approximate 1,280-acre drilling and spacing unit for the Application Lands, and the authority to drill 12 horizontal wells within the proposed unit, for production of oil, gas and associated hydrocarbons from the Codell, Fort Hays, Carlile, and Niobrara Formations. Further, the establishment of the drilling and spacing unit is not smaller than the area which can be efficiently and economically drained by the drilling of the requested horizontal wells to be drilled within said unit.
- 10. Applicant herein requests the treated interval of any horizontal well permitted under this Application should be located not less than 300 feet from proposed unit boundaries and **not less than 150 feet from the productive interval of any other well producing or drilling in the unit**, without exception being granted by the Director.
- 11. Further, Applicant herein requests any permitted wells drilled under this Application should be located on no more than four multi-well pads within the drilling and spacing unit, or on adjacent lands with surface owner consent, without exception being granted by the Director.

- 12. The granting of this Application is in accord with the Oil and Gas Conservation Act found at §34-60-101, et seq., C.R.S., and the COGCC rules.
- 13. Applicant requests that relief granted as result of this Application should be effective on oral order by the Commission, and Applicant hereby agrees to be bound by the oral order of the Commission.
- 14. That the names and addresses of interested parties (owners within the Application Lands and Section 36, Township 10 North, Range 60 West, 6th P.M., and those owners of lands cornering or adjacent to the Application Lands) according to the information and belief of the Applicant are set forth in

<u>Exhibit B</u>. The Applicant shall submit a certificate of service for the Application with the legal Notice of Hearing for same.

WHEREFORE, Applicant respectfully requests this matter be set for hearing, notice be given as required by law, and that upon such hearing the Commission enter its order:

- A. Modifying Order No. 535-59 to reduce the number of authorized wells to one horizontal well within the approximate 960-acre drilling and spacing unit established for the S½ of Section 25 and Section 36, Township 10 North, Range 60 West, 6th P.M., for production of oil, gas and associated hydrocarbons from the Niobrara Formation, and maintaining allocation of proceeds for any existing wells located within said unit and producing from the Niobrara Formation.
- B. Vacating the approximate 960-acre drilling and spacing unit established by Order No. 535-151 for Section 24 and the $N\frac{1}{2}$ of Section 25, Township 10 North, Range 60 West, 6^{th} P.M., which authorized the drilling of four horizontal wells within each unit, for production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- C. Establishing an approximate 1,280-acre drilling and spacing unit for the Application Lands, and authorizing the drilling of 12 horizontal wells within the proposed unit, for the production of oil, gas and associated hydrocarbons from the Codell, Fort Hays, Carlile, and Niobrara Formations, with the treated interval of any horizontal well permitted under this Application located not less than 300 feet from unit boundaries and **not less than 150 feet from the productive interval of any well in the unit**, without exception being granted by the Director.
- D. Limiting the drilling of any permitted wells under this Application to no more than four multi-well pads within the drilling and spacing unit, or on adjacent lands with surface owner consent, without exception being granted by the Director.
- E. For such other findings and orders as the Commission may deem proper or advisable given the premises.
