APPLICATION

PDC Energy, Inc. (Operator No. 69175) ("PDC"), by and through its attorneys, Burns, Figa, & Will, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order pooling all interests within four approximate 400-acre Wellbore Spacing Units, as further defined below, for the drilling of the Barr 11L-221 Well (API No. 05-123-45683), Barr 11L-301 Well (API No. 05-123-45682), Barr 11L-401 Well (API No. 05-123-45688), and the Barr 11L-201 Well (API No. 05-123-45692) ("Wells"), for the development of the Niobrara and Codell Formations on the following described lands:

Township 5 North, Range 65 West, 6th P.M.

Section 12: W½
Section 13: N½NW¼

Weld County, Colorado, containing approximately 400.00 acres ("Application Lands")

In support of its Application, PDC states and alleges as follows:

- 1. PDC is a corporation duly authorized to do business in Colorado and is registered as an operator in good standing with the Commission.
- 2. PDC is an Owner with the right to drill into and produce from the Application Lands.
- 3. On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well, and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of Greater Wattenberg Area wells. On December 5, 2005, Rule 318A was amended, among other things, to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address drilling of horizontal wells. The W½ of Section 12 and the

N½NW¼ of Section 13, Township 5 North, Range 65 West, 6th P.M., are subject to Rule 318A for the Niobrara and Codell Formations.

- 4. On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formations, the Codell Formation, and the Niobrara Formation underlying certain lands, including the W½ of Section 12 and the N½NW¼ of Section 13, Township 5 North, Range 65 West, 6th P.M., with the permitted well locations in accordance with the provisions of Order 407-1.
- 5. On July 24, 2017, the Commission entered Order No. 407-2160, which, among other things, pooled all non-consenting interests in three approximate 720-acre wellbore spacing units for the W½E½, E½W½ of Section 12, W½E½, E½W½ of Section 13, and the NW¼NE¼, NE¼NW¼ of Section 24, Township 5 North, Range 65 West, 6th P.M., for the Sandin 24N-241 Well (API No. 05-123-44667), Sandin 24N-301 Well (API No. 05-123-44663), from the Niobrara Formation. Order No. 407-2160 is not affected by this Application, and proceeds from any shared lands will be accounted for in the production of the Wells.
- 6. As of the date of this Application, the COGCC has not published any additional orders affecting spacing of the Application Lands.
- 7. PDC designated four approximate 400-acre Wellbore Spacing Units for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations as provided by Rule 318A and notified the appropriate parties under Rule 318A.
- 8. Under the provisions of Rule 530 and C.R.S. § 34-60-116(6)–(7), PDC requests an order pooling all interests, including non-consenting interests and the ability to drill through all tracts, in the Application Lands for the development of the Niobrara and Codell Formations underlying four approximate 400-acre Wellbore Spacing Units for the Barr 11L-221 Well (API No. 05-123-45683), Barr 11L-301 Well (API No. 05-123-45682), Barr 11L-401 Well (API No. 05-123-45688), and the Barr 11L-201 Well (API No. 05-123-45692:

Wellbore Spacing Units (each approximately 400.00 acres):

Barr 11L-221 Well (API No. 05-123-45683) - Niobrara

Barr 11L-301 Well (API No. 05-123-45682) - Niobrara

Barr 11L-401 Well (API No. 05-123-45688) - Codell

Barr 11L-201 Well (API No. 05-123-45692 - Niobrara

Township 5 North, Range 65 West, 6th P.M.

Section 12: W1/2

Section 13: N½NW¼

Weld County, Colorado ("Wellbore Spacing Units" in this Application)

- 9. PDC requests that the Commission's pooling order be made effective as of the earlier date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Barr 11L-221 Well, Barr 11L-301 Well, Barr 11L-401 Well, and the Barr 11L-201 Well to the Niobrara and Codell Formations on the Application Lands.
- 10. PDC certifies that copies of this Application will be served on all owners of the mineral estate, as indicated and required by Rule 507.b(2), underlying the tracts of the Application Lands to be pooled within seven (7) days of the date hereof, and that at least sixty (60) days prior to the hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease, or to participate in the drilling of the Wells, and will be provided with the information required by Rule 530. The list of such Interested Parties, with all known parties to be pooled, is attached as Exhibit A.
- 11. In order to prevent waste and to protect correlative rights, all interests and tracts in the Wellbore Spacing Units should be pooled for the orderly drilling and development of the Niobrara and Codell Formations.

WHEREFORE, PDC respectfully requests that this matter be set for hearing at the next available opportunity, that notice be given as required by law, and that the Commission enter an Order:

- A. Pooling all interests in the Application Lands and the Wellbore Spacing Units for the development of the Niobrara and Codell Formations;
- B. Providing that the Commission's pooling order is made effective as of the earlier date of the Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Barr 11L-221 Well, Barr 11L-301 Well, Barr 11L-401 Well, and the Barr 11L-201 Well in the Wellbore Spacing Units to the Niobrara and Codell Formations on the Application Lands;
- C. Providing that the interests of any owners with whom PDC has been unable to secure a lease, other agreement to participate in the drilling of the authorized well(s), or those who consented to be pooled are pooled by operation of statute, pursuant to C.R.S. § 34-60-116(7), and made subject to the cost recovery provisions thereof with respect to the Barr 11L-221 Well, Barr 11L-301 Well, Barr 11L-401 Well, and the Barr 11L-201 Well drilled to develop the Niobrara and Codell Formations in the Wellbore Spacing Units comprised of the Application Lands; and
- D. Providing for such other findings and order as the Commission may deem proper or advisable in this matter.
