SRC Energy Inc. (Operator No. 10311) ("SRC" or "Applicant"), by and through its attorneys, Beatty & Wozniak, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order amending Commission Order No. 407-2166, only as to Wellbore Spacing Unit No. 5, to amend the Application Lands for the AG 4N-31B-L Well, for the production of oil, gas, and associated hydrocarbons from the Niobrara Formation. In support of its Application, Applicant states and alleges as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado, and has registered as an operator with the Commission.
 - 2. Applicant is an owner in the below-listed lands:

Township 6 North, Range 66 West, 6th P.M.

Section 31: N½
Section 32: N½

Section 33: W½NW¼

Township 6 North, Range 67 West, 6th P.M.

Section 36: NE1/4NE1/4

771.886 acres, more or less, in Weld County, Colorado¹

These lands are hereinafter referred to as the "Application Lands" and depicted in Exhibit A attached hereto.

3. On April 27, 1998, the Commission adopted Rule 318A. which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A. was amended to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A. was again

¹ The Application Lands contain irregular lots. Acreage in this area is based on the known survey markers found in the field. Accordingly, the acreage comprising the drilling and spacing unit has been modified to reflect the presence of irregular quarter-quarter sections.

amended to, among other things, address drilling of horizontal wells. The Application Lands are subject to Rule 318A.

4. On July 24, 2017, the Commission entered Order No. 407-2166 which, among other things, pooled all interests in five approximate 811.886 wellbore spacing units for the below-described lands for the development and operation of the Niobrara and Codell Formations:

Township 6 North, Range 66 West, 6th P.M.

Section 31: N½
Section 32: N½

Section 33: W1/2NW1/4

Township 6 North, Range 67 West, 6th P.M.

Section 36: E½NE¼

Wellbore Spacing Unit ("WSU") Nos. 1-5

AG 31C-31-L Well (Codell Formation)

AG 31N-31C-L Well (Niobrara Formation)

AG 4C-31-L Well (Codell Formation)

AG 4N-31B-L Well (Niobrara Formation)

811.886 acres, more or less, in Weld County, Colorado.

- 5. WSU No. 5 was pooled for the AG 4N-31B-L Well, for production from the Niobrara Formation, based on the initial plan for the AG 4N-31B-L Well. As drilled, the AG 4N-31B-L Well has not been completed into the NE½NE½ of Section 36, Township 6 North, Range 67 West, 6th P.M. thus resulting in a modification to the wellbore spacing unit for the AG 4N-31B-L Well that would exclude the SE½NE½ of Section 36, Township 6 North, Range 67 West, 6th P.M. See Exhibit B, Spacing Unit Map. Applicant has filed the necessary Form 4 Sundry Notice with the Commission for the AG 4N-31B-L Well. Further, Applicant has provided courtesy letters to the appropriate parties within the modified WSU No. 5, an example of which is attached hereto as Exhibit B. There were no new parties to be noticed as a result of the unit restriction.
- 6. Applicant requests Order No. 407-2166 be amended to modify WSU No. 5, thereby pooling the interests for the Application Lands, resulting in an approximate 781.866-acre wellbore spacing unit for development and operation of the Niobrara Formation, effective as of the earlier of the date of Pooling Order No. 407-2166, or the date the costs specific in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the AG 4N-31B-L Well.
- 7. The granting of this Application is in accordance with the Oil and Gas Conservation Act, found at §§34-60-101, *et seq.*, C.R.S., and the Commission rules.
- 8. Applicant requests that relief granted under this Application should be effective on oral order by the Commission, and Applicant hereby agrees to be bound by said oral order.

9. The undersigned certifies that copies of this Application will be served on each interested party as required by Rule 507 within seven (7) days of the filing hereof, as required by Rule 503.e.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing, this Commission enter its order:

- A. Amending Pooling Order No. 407-2166 to account for the adjustment to WSU No. 5, and thereby pool the interests in the Application Lands, being an approximate 781.866-acre wellbore spacing unit for development and operation of the Niobrara Formation, effective as of the earlier of the date of Pooling Order No. 407-2166, or the date the costs specific in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the AG 4N-31B-L Well.
- B. For such other findings and orders as the Commission may deem proper or advisable in the premises.






