APPLICATION

PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), by and through its attorneys Burns, Figa & Will, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order to: establish an approximate 2,560-acre drilling and spacing unit for the Application Lands for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell formations, and approve up to thirty-four (34) horizontal wells drilled from a maximum of four (4) well pads for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell formations on the following described lands:

Township 7 North, Range 65 West, 6th P.M.

Section 18: W1/2

Township 7 North, Range 66 West, 6th P.M.

Section 11: All Section 13: All Section 14: All

Section 15: S1/2

Weld County, Colorado (containing a total of approximately 2,560 acres)

Referred herein as the "Application Lands." A reference map depicting the Application Lands is attached hereto and marked as <u>Exhibit B</u>.

In support of its Application, PDC states and alleges as follows:

- 1. PDC is a corporation duly authorized to do business in Colorado and is registered as an operator in good standing with the Commission.
- 2. PDC is an Owner with the right to drill into and produce from the Application Lands.
- 3. On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well, and to commingle any or all of the Cretaceous Age Formations from

the base of the Dakota Formation to the surface. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of Greater Wattenberg Area wells. On December 5, 2005, Rule 318A was amended, among other things, to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address drilling of horizontal wells. The Application Lands are subject to Rule 318A for the Codell and Niobrara Formations.

- 4. On June 1, 2015, the Commission entered Order No. 407-1311, which, among other things, pooled an approximate 400-acre wellbore spacing unit for the Thornton 14K-441 Well (API No. 05-123-38759), consisting of the SW¼ and S½NW¼ of Section 11, and the NW¼ of Section 14, all of Township 7 North, Range 66 West, 6th P.M., for the production of oil, gas, and associated hydrocarbons from the Codell formation. PDC excludes from this Application the Thornton 14K-441 Well and asserts that the production and payments from the Thornton 14K-441 Well should be maintained under the authority of Order No. 407-1311 and other applicable Commission orders and rules.
- 5. On August 4, 2015, the Commission entered Order No. 407-1344, which, among other things, pooled an approximate 560-acre designated horizontal wellbore spacing unit for the Tracy 14P-432 Well (API No. 05-123-38737), comprising the S½ of Section 13 and the SE¼ of Section 14, all of Township 7 North, Range 66 West, 6th P.M., and the W½SW¼ of Section 18 of Township 7 North, Range 65 West, 6th P.M. for the production of oil, gas, and associated hydrocarbons from the Codell formation. PDC excludes from this Application the Tracy 14P-432 Well and asserts that the production and payments from the Tracy 14P-432 Well should be maintained under the authority of Order No. 407-1344 and other applicable Commission orders and rules.
- 6. On August 4, 2015, the Commission entered Order No. 407-1346, which, among other things, pooled an approximate 320-acre designated horizontal wellbore spacing unit for the Thornton 18L-401 Well (API No. 05-123-39562), consisting of the SW¼ and S½NW¼ of Section 11, and the NW¼ of Section 14, all of Township 7 North, Range 66 West, 6th P.M., for the production of oil, gas, and associated hydrocarbons from the Codell formation. PDC excludes from this Application the Thornton 18L-401 Well and asserts that the production and payments from the Thornton 18L-401 Well should be maintained under the authority of Order No. 407-1346 and other applicable Commission orders and rules.
- 7. On August 4, 2015, the Commission entered Order No. 407-1415, which, among other things, pooled two approximate 320-acre wellbore spacing units for the Waag #1 Well (API No. 05-123-40342) and the Waag #2 Well (API No. 05-123-40343) ("Waag Wells"), consisting of all or portions of the S½SW¼ of Section 18, the N½NW¼ of Section 19, all of Township 7 North, Range 65 West, 6th P.M., and the S½SE¼ of Section 13 and the N½NE¼ of Section 24, all of Township 7 North, Range 66 West, 6th P.M., for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara formations. PDC excludes from this Application the Waag Wells and asserts that

the production and payments from the Waag Wells should be maintained under the authority of Order No. 407-1415 and other applicable Commission orders and rules.

- 8. PDC excludes from this Application all existing wellbore spacing units located on the Application Lands, to the extent they are still producing, and asserts that the production and payments from the existing wellbore spacing units should be maintained under the authority of all applicable Commission rules and orders.
- 9. PDC excludes from this Application all existing vertical and directional wells located on the Application Lands, to the extent they are still producing, and asserts that the production and payments from the existing vertical and directional wells should be maintained under the authority of all applicable Commission rules and orders.
- 10. The proposed approximate 2,560-acre drilling and spacing unit is not smaller than the maximum area that can be economically and efficiently drained by the proposed wells.
- 11. PDC requests that the Commission approve the development of up to thirty-four (34) horizontal wells in the proposed approximate 2,560-acre drilling and spacing unit for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara formations. The proposed wells will be drilled from surface locations described in Rule 318A or on other lands with consent of the landowner, unless an exception is granted by the Director. The wells will be stacked by formation to comply with the minimum distances from the outer boundaries of the proposed drilling and spacing unit and from any other well producing from the Codell and Niobrara Formations.
- 12. Applicant states that, for any permitted wells to be drilled under this Application, the productive intervals of the wellbores shall be no less than 150 feet from the unit boundaries for the heels and toes of any horizontal well, and no less than 460 feet from the unit boundaries for the productive intervals of any horizontal well that is parallel to the unit boundary. PDC will provide engineering testimony that demonstrates the compatible east/west, west/east, and south/north orientation of horizontal wells in the proposed unit. Applicant further states that the interwell setbacks shall be no less than 150 feet from the productive interval of any other well producing from the Niobrara and Codell formations, unless an exception is granted by the Director.
- 13. The proposed wells shall be drilled from a maximum of four (4) well pads located within the approximate 2,560-acre drilling and spacing unit, or on adjacent lands with consent of the landowner, unless an exception is granted by the Director.
- 14. The granting of this Application is in accordance with the Oil and Gas Conservation Act, C.R.S. § 34-60-101 et seq., and the Commission Rules.
- 15. PDC requests that the relief granted under this Application be effective upon oral order of the Commission, and PDC hereby agrees to be bound by such oral order.

16. The names of the interested parties, according to PDC's information and belief, are set forth in the attached Exhibit A, and the undersigned certifies that copies of this Application will be served on each interested party at least thirty-five (35) days in advance of any Commission hearing at which the matter will first be heard, pursuant to Rule 507.

WHEREFORE, PDC respectfully requests that this matter be set for hearing at the next available opportunity, that notice be given as required by law, and that the Commission enter an Order to:

- A. Establish an approximate 2,560-acre drilling and spacing unit for the Application Lands and approve up to thirty-four (34) horizontal wells in the proposed unit, for production of oil, gas, and associated hydrocarbons from the Niobrara and Codell formations;
- B. Require the productive interval of the wellbore of any permitted wells in the unit to be located no closer than 150 feet from the unit boundaries for the heels and toes of horizontal wells in the unit, and no closer than 460 feet from the unit boundaries for the productive interval of any horizontal well that is parallel to the unit boundary;
- C. Require that the productive interval of the wellbore of any permitted wells in the unit be located no closer than 150 feet from the productive interval of any other wellbore located in the unit; and
- D. Provide that the wells shall be drilled from a maximum of four (4) well pads within the unit subject to Rule 318A or on adjacent lands, unless an exception is granted by the Director.
