APPLICATION

On March 2, 2017, Crestone Peak Resources Operating, LLC, Operator No. 10633 ("Crestone" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in four approximate 548.44-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Woolley Sosa 2C-7H-E168 Well (API No. 05-123-39245) (WSU #1), the Woolley Sosa 2D-7H-E168 Well (API No. 05-123-38106) (WSU #2), the Woolley Sosa 2E-7H-E168 Well (API No. 05-123-38110) (WSU #3), and the Woolley Sosa 2F-7H-E168 Well (API No. 05-123-38113) (WSU #4).
