On March 2, 2017, Crestone Peak Resources Operating, LLC, Operator No. 10633 ("Crestone" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in six approximate 640-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Morgan Hills 1B-7H-A168 Well (API No. 05-123-43301) (WSU #1), the Morgan Hills 1C-7H-A168 Well (API No. 05-123-43300) (WSU #2), the Morgan Hills 1D-7H-A168 Well (API No. 05-123-43299) (WSU #3), the Morgan Hills 1E-7H-A168 Well (API No. 05-123-43296) (WSU #4), the Morgan Hills 1F-7H-A168 Well (API No. 05-123-43303) (WSU #5), and the Morgan Hills 1G-7H-A168 Well (API No. 05-123-43302) (WSU #6).


Additional information about the hearing on this Application will be in the Commission's Agenda, which is posted on the Commission website approximately 3 days before the hearing.
